**General booking conditions**  
**(Prices are inclusive of VAT : 10% VAT included)**

All rentals are personal and cannot be transferred or rented under any circumstances.

Minors must be accompanied by their parents or legal guardians. Reservations can be made via our website, by e-mail or by telephone, but with written confirmation (contract signed with deposit) within 7 days. After this period, the option will be canceled without notice.

**LOCATIONS:** arrival 2 p.m. and departure at 12 p.m.

The balance of the stay is to be paid on site upon arrival.

**RENTALS:** arrival between 3 p.m. and 7 p.m. and departure before 10 a.m. For departure, you must come and make an appointment at reception during your stay. The slots are between 8:30 a.m. and 10 a.m.

In the event of late arrival or early departure, the dates reserved will be due in full, including the fees attached to them.

For the payment, we ask for a deposit of 30% on booking and the balance of the stay is to be paid 30 days before the date of arrival. In the absence of payment within this period, your reservation will be automatically canceled.

When sending the balance, please send us two deposit checks, one for 300 € and one for 70 €. If you do not wish to send them, please prepare them in advance in order to provide them on your arrival to avoid any delay in check-in. It is also possible to deposit your deposit online in your customer area. These deposits will be returned to you by post within 8 days, under conditions of making the mobile home clean and without damage.

A mobile home that has been left clean must be able to be re-let without any additional cleaning. Otherwise, the deposit of 70 € will be debited.

**For your comfort, remember to bring your own sheets, pillowcases and towels.**

**Reservations are kept until 11 a.m. the day after your scheduled arrival date. After this period and without any news from you, the rentals in pitches will no longer be reserved.**

**Cancelation :**

In the event of cancellation, you will be retained or will remain due: reservation costs and as compensation for breach of contract: an amount equal to 30% of the total cost of your stay if you cancel more than 30 days before the expected date of arrival, an amount equal to the total of your stay if you cancel less than 30 days before the date of your arrival.

**All cancellations must be made by registered letter with proof. No refund will be made on early departures.**

**Rules of procedure**

The camper is required to respect the internal rules of the campsite as well as those of the swimming pools. The campsite is not responsible for any damage or degradation that may occur to the personal property of campers.

Category 1 and 2 dogs are prohibited. Dogs must be tattooed, vaccinated and kept on a leash within the campsite.

The management reserves the right to evict without notice or reimbursement those who fail to respect the internal regulations or who have given false information concerning the occupants of the plot.

**Circulation:** the speed is limited to 10km / h. The gates are closed between 11 p.m. and 7 a.m. All traffic is prohibited on the campsite during this last period.

**Disputes/Complaints:** Any complaint related to a stay must be made in writing and sent to us by registered letter with acknowledgment of receipt within 20 days of the end of the stay. In the event of a dispute and if an amicable solution is not found within one month of receiving the aforementioned letter of complaint, you may contact a consumer mediator free of charge, provided you contact them within one year of sending your letter of complaint.
